The Accrediting Commission for Community and Junior Colleges, at its meeting January 8-9, 2025, reviewed the Institutional Self-Evaluation Report (ISER) and evidentiary materials submitted by Lake Tahoe Community College. The Commission also considered the Peer Review Team Report (Team Report) prepared by the peer review team that conducted its site visit to the College September 30 – October 1, 2024.

The purpose of this review was to determine whether the College continues to meet ACCJC's Eligibility Requirements, Commission Policies, and Accreditation Standards (hereinafter, the Standards). Upon consideration of the written information noted above, the Commission acted to Reaffirm Accreditation for seven years.

The next report from the College will be the Midterm Report<sup>1</sup> due on October 15, 2028. The institution's next comprehensive review will begin with Team ISER Review in the spring term of 2031 and conclude with a Focused Site Visit in the fall term of 2031.

On behalf of the Commission, we wish to express appreciation for the diligent work and thoughtful reflection that Lake Tahoe Community College undertook to prepare for this review. These efforts confirm that peer review can serve the multiple constituencies of higher education by both ensuring and encouraging institutional quality and effectiveness.
